Terms and Conditions

1. The adopter agrees to pay RDR an adoption fee of \$_____ which is non-refundable. _____
2. The adopter agrees to provide a lifelong commitment, comfortable environment, prompt medical attention, proper grooming, and responsible care to their new pet. This includes keeping your pet parasite free and up to date with vaccinations, proper nutrition, which consists of a good quality professional feed given at regular intervals, and fresh water available at all times. This pet is being adopted as a companion animal, and as such, will spend the majority of its time indoors with the family. _____
3. The adopter promises to provide a safe environment for their new pet, and never allow their pet to roam freely without proper fencing or supervision. RDR strongly recommends that your new pet be microchipped or tattooed in order to facilitate his/her return if lost or stolen. _____
4. The adopter will not allow their pet to ride freely in the back of a pickup truck, and this pet is NOT to be chained outside unattended at any time. When the pet is outdoors, he/she shall be provided protection from the elements. _____
5. The adopter agrees not to use this pet for breeding and agree to have it spayed/neutered at the age recommended by their veterinarian, if it is not done prior to adoption. _____
6. RDR makes no statements or warranties regarding the pet’s future health, medical status, or temperament. Information will be provided by RDR as to the

known health history of this animal, but these animals are rescues, and their past is usually unknown. _____

7. RDR recommends that prior to adopting animals of unknown health history; adopters ensure that their current pets are current on all vaccinations. _____
8. The adopter agrees to contact RDR immediately if any questions or concerns arise about this pet, such as housing, diet, health, or training. The adopter agrees to keep RDR informed of any treatment, as it occurs. This provides RDR an opportunity to follow up on animals and gives us important feedback and information on the health of our pets.
9. In the event that RDR discovers the inhumane treatment of this pet or breach of this contract, it is agreed that RDR has the right to immediately re-take possession of this pet. It is understood that home visits may be made to check on the welfare of this animal. _____
10. If at any time the adopter can no longer retain possession of their pet, the animal is to be returned to RDR. RDR is available for consultation, advice, and assistance in all areas pertaining to health, training, compatibility, and etc. of the adopted pet. No refunds will be given if the adopter is no longer able to care for their pet and it is returned to RDR. Under NO CIRCUMSTANCES will this pet be sold, leased, traded, or given away to any pet shop, laboratory, animal shelter, or similar facility. _____
